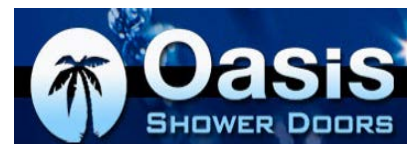

## EDUCATION AT A GLANCE

All Construction Supervisor license holders are required to complete the appropriate number of mandatory continuing education credits each 2-year cycle. An unrestricted license requires 12 hours of classes, a restricted license requires 10 hours, and a specialty license requires 6 hours. Of these credits each must be in the following hours & categories: 4hrs. Code, 1hr. Safety, 1hr. Business, 1hr. Energy & 1hr. Lead Safety (first time only). Specialty license holders require 2hrs. Code, 1hr. Safety, 1hr. Business, 1hr. Energy & 1hr. Lead Safety (first time only).

- *Classes on January 13, March 3 and April 22 are designed for contractors with a Specialty License that only need six credit hours to renew their license.*
- *For Unrestricted or Restricted License Holders, you will need to take two days of classes to full fill all your education renewal requirements. You can take one day of in-classroom instruction and take the other six credits online.*
- *As of September 15, 2021, contractors can only take a maximum of six credit hours on-line. All other credits must be obtained through in-class instruction.*
